Clerkship Attendance Policy

PURPOSE

This policy will define the policy and procedure for Clinical Enrichment while in the clerkship.

POLICY AND PROCEDURES

- 1. MSUCOM approved Clinical Enrichment provides the opportunity for a student to gain experience in a field of medicine while ensuring medical liability coverage and supervision.
 - a. Optimal times of use may be in year 3 to explore fields of interest and in year 4 to explore residency programs of interest when unable to schedule an audition elective.
- **2.** The student must complete the Clinical Enrichment Application and have approval from the MSUCOM clerkship team prior to any Clinical Enrichment experience.
- 3. MSUCOM Clinical Enrichment experiences may be utilized by an MSUCOM clerkship student in one of two ways:
 - a. While on an enrolled/assigned rotation
 - i. A clerkship student, while on an enrolled/assigned rotation, may utilize Clinical Enrichment to gain experience outside of the assigned rotation in an interested field of medicine.
 - ii. Clinical Enrichment may only be utilized if there are gap times on the enrolled/assigned rotation. A student is not permitted to take personal time off

or miss any enrolled rotation activities, commitments, or requirements to complete clinical enrichment.

- iii. The student can apply for one enrichment experience field per rotation. Example: if the student is enrolled in a pediatrics course/rotation and has received MSUCOM approval for Clinical Enrichment in emergency medicine, the enrichment is only allowed in emergency medicine.
- iv. A student may participate in clinical enrichment only upon approval from MSUCOM clerkship.
 - **1.** Once approved, the student may participate in the approved enrichment experience throughout the enrolled course.
 - **2.** When the student moves to another enrolled rotation, the student will need to complete another enrichment form.
- b. While on vacation
 - i. A clerkship student, while on vacation, may utilize Clinical Enrichment to gain experience in a field of interest.
 - ii. The student may spend a maximum of one week on the clinical enrichment experience while on vacation
 - iii. Due to limited staffing available during the December vacation time, students who wish to complete a Clinical Enrichment during the December vacation must have their application submitted to the Clerkship team by December 10th.
- **4.** The student's Clinical Enrichment experience must comply with the MSUCOM Duty Hours and Fatigue Mitigation Policy.
- 5. No credit is received for Clinical Enrichment
- 6. A student must have active enrollment in courses in the same semester the clinical enrichment occurs.
- 7. No evaluations are required during Clinical Enrichment.
- 8. Clinical Enrichment will not appear on MSU transcripts.

- 10. Failure to comply with the policy will result in submission to the CGPI professionalism committee.
