Responsible and Ethical Conduct of Research (RECR) Training Checklist

Responsible and Ethical Conduct of Research (RECR) training is a degree <u>requirement</u> for all students in the Michigan State University College of Osteopathic Medicine (MSUCOM). RECR topics address the responsibilities of MSUCOM students in both basic biomedical and clinical research during their curriculum. Students will complete their RECR requirements through mandatory face-to-face instruction sessions, developed by MSUCOM Office of Research, along with CITI (Collaborative Institutional Training Initiative) Training System's online modules.
